The Lodge tyled at 4.37pm and was opened in due form and solemn prayer by the WM at 4.47pm

The minutes of the last regular meeting, having been circulated to all members, were confirmed and the WM and Wardens signed them off as a true and correct record.

The Secretary presented the report of the Inventory Committee. The goods and chattels of the Lodge were found to be in good order.

The DC welcomed WBro Paul Aspinall, PAGDC, the Representative of the RW Provincial Grand Master. The usual salutations were offered for which WBro Aspinall thanked the Lodge.

The WM, proposed that the sum of £1,000 be donated to the ELMC. This was seconded by the Secretary, WBro MN Ashton *JP* and was, eventually, passed unanimously by the brethren.

The WM asked all EA's to retire from the Lodge for a short time after which the Lodge was opened in the 2nd Degree.

The WM invited WBro TW Hankins to act as Installing SW.

WBro DA Kyme presented Bro H Wood, SW and Master Elect. The qualifications necessary for the office of Master were given by the WM and the Antient Charges and regulations were read to Bro Wood by the Secretary, to which he gave his unqualified assent.

The ME entered into his Obligation and thereafter took a seat in the NE.

The WM invited WBro MJS Bailey to be the Installing JW and WBro MN Ashton JP, as Installing IG.

The WM requested that all brethren below the rank of a Master Mason retire from the lodge. At this point all FC's retired from the Lodge for a short time after which, the WM opened the Lodge in the Third Degree.

The Officers of the Lodge returned their Collars and Jewels of office to the WM who thanked them individually for their support during his tenure of office. All brethren below the rank of an Installed Master, apart from Bro Wood, retired from the Lodge.

The WM opened a duly constituted Board of Installed Masters.

Bro Wood took the obligation of a Master in the Chair and was installed, according to antient custom, as the 116th Worshipful Master of the Earl of Lathom Lodge, being numbered 2560 in the register of the United Grand Lodge of England, for the ensuing 12 months.

The WM invested WBro AG Bradshaw as his IPM with the Collar and Jewel of his office and the Past Masters congratulated the WM on his installation and the IPM on his year of Office.

The DC then declared a comfort break of 15 mins which lasted 23 minutes.

The Board of Installed Masters reconvened and was closed. The Lodge resumed in the Third Degree. MM's were admitted and, for the first time, Bro Wood was proclaimed as WM in the East by the Acting DC, WBro TW Hankins, who presented the Working Tools of this degree to the WM. The Lodge was closed by virtue from the Third Degree to the Second by the Acting DC and FC's were admitted. Bro Wood was proclaimed as WM in the west by the Acting DC, who presented the Working Tools of this degree to the WM.

The Lodge was closed by virtue from the Second Degree to the First by the Acting DC and EA's were admitted. Bro Wood was proclaimed as WM in the south by the Acting DC, who presented the Working Tools of this degree to the WM.
